## Community Development Block Grant

- National Objective: Benefit LOW/MODERATE INCOME Persons
- Restriction on location of activities (24 CFR 570.309 ):
  - Sub recipients funded by OSI will only provide services to persons who reside in the Brownsville Area.

## Eligible Public Service Activities:

- Provision of public services including but not limited to general welfare services such as:
  - food and clothing services
  - health services
  - educational services
  - youth enrichment and juvenile delinquency prevention programs
  - employment and job development services.

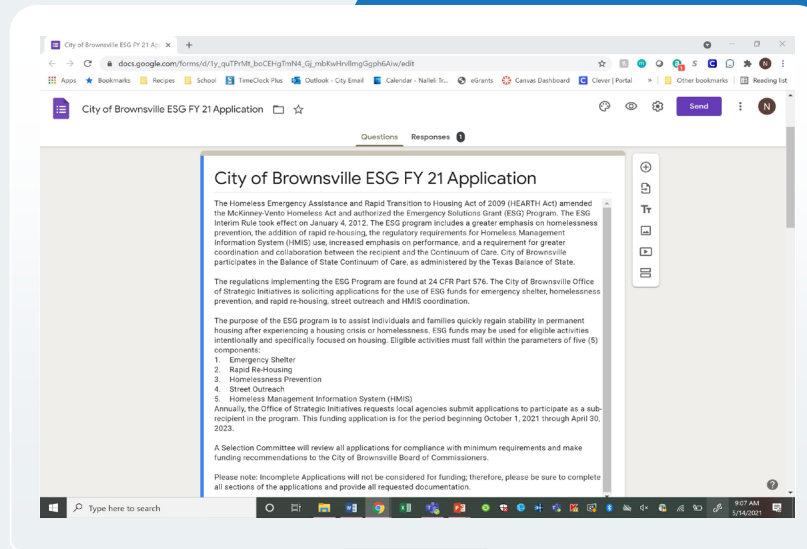
